#### **Future of Primary ITO**

We are waiting on final decisions from the Government on what the vocational sector will look like in the future. Tertiary Education Minister Penny Simmonds is planning for a proposal to Cabinet by the end of June. It will then make its decisions and we expect an update some time after that.

As an interim step, while we remain a business division of Te Pūkenga – the New Zealand Institute of Skills and Technology, like other ITOs we have returned to our single Primary ITO branding. Changes to legislation need to be made to fully disestablish Te Pūkenga, which may take a significant amount of time. In the meantime, the team will continue to be here to provide support and guidance and continue with our current work.



### **Defendable Assessor Decisions**

How would your assessment decisions stand up in court?

Would your assessment documents and the decisions you marked as Achieved withstand the scrutiny of a legal investigation?

Many activities in primary industries carry inherent risk particularly around the use of machinery and vehicles and sadly serious injuries and deaths from Quad bikes, LUVs and tree felling activities continue to feature in the headlines.

During an investigation into workplace accidents, training records and assessment are looked at by WorkSafe or in

the case of death by a coroner, so it's important that you can show defendable, fact-based evidence that you assessed correctly.

### **ChatGPT**

You may have heard of **ChatGPT**. This Al-powered language app is capable of generating human-like text based on context and past conversations. While it is a useful tool to gain information, it should not be used by learners to answer questions within their assessments - this is considered plagiarism, like copying someone else's work or having somebody complete your assessment for you.

# What if you suspect that one of your learner's is using ChatGPT?

### DO your own check using the APP.

- a) Open up ChatGPT and type in the exact question word for word into the application.
- b) <u>Compare</u> the response from ChatGPT to the learner's answer.
- c) If you see commonality of words, and you think that the learner would not normally use these words or there is no reference to these words in any learner resource provided, then chances are it is being used.

#### **Question the Learner**

Have a conversation with the learner about how they arrived at the answers in question. Discuss what was meant by the answer and allow the learner to explain their answer to you. You should then be able to gauge if the learner knows the answer or if they might be using ChatGPT or any other form of plagiarism.

# **Programme Evaluations update**

Programme evaluations are internal reviews to gain a snapshot understanding of how our programmes are working in the field, how learners are achieving, how well they meet the needs of industry, and whether learning and assessment supports achievement.

**3129 NZ Certificate in Seafood (Level 5) qualification** was reviewed recently. There is no programme for this qualification, however with a cohort of apprentices beginning to graduate from the Level 4 qualification, ensuring there is a pathway into further training at Level 5 is a priority. Options are being explored as part of the review of the qualification currently taking place with Muka Tangata.

The Level 5 short programme for HACCP Co-ordinators was reviewed concurrently. This specialist programme is very successful for those who enrol, with 100% completion rate. It is a success story for ākonga Māori, who have achieved above parity in this programme. A career pathway in Seafood at Level 5 is important for Māori as owners of over 40% of Aotearoa's fisheries and 100% of customary fisheries.

# **NZQA Consistency Reviews**

NZQA recently conducted consistency reviews of the following qualifications:

2378 NZ Certificate in Equine (Therapeutic Riding – Assistant Coach) Level 3 was reviewed in May and consistency was confirmed. The reviewer was impressed with the quality of evidence presented. Recommendations included considering whether the extent of basic horse care and riding content is relevant for ākonga who already have a strong equine background.

**2224 NZC in Apiculture (Level 4)** was reviewed in April and consistency was confirmed. Again, Primary ITO's self-assessment processes were considered of high quality and NZQA had no recommendations for this qualification.



## **Moderation Update**

Workplace Assessors in Rural Pest Operations were moderated in the first quarter of the year and showed excellent consistency in assessing to the national standard with all Assessors being found complaint.

Vehicles and Machinery and Equine Sector moderations were completed in Quarter 2 with a mix of moderation outcomes. Some common issues found were:

- Some learner answers were incorrect or had insufficient depth for the level being assessed.
- A lack of verifier/assessor comments to support competency.
- The Assessment tool was old or requires revision to capture all the required evidence.



Meat Processing and Apiculture moderations are currently underway. Horticulture moderations will commence shortly including Arboriculture, Sports Turf and Landscape with a Panel Moderation event being held at the end of August.

This is a friendly reminder that all Assessors are obligated to participate in moderation activities when requested, otherwise this may put their registration at risk. If you are unsure of what is required, please don't hesitate to call us and we will guide you through the process.
